#### School vision statement

Teachers meet and collaborate in teams to develop common learning programs, utilise unique or shared knowledge and skills, and develop our students, including those students from a non–English speaking or Aboriginal background. Our school also caters for students with specific learning needs through the provision of four support classes.


#### School planning process

The school self–evaluation process is transparent and inclusive of all stakeholders. In 2017, in conjunction with the External Validation process, the school conducted a number of surveys to ascertain the viewpoints of parents, students and staff.

Through the P&C and School Council, parents were encouraged to participate in discussions and surveys around our school culture and in particular what works well at our school and what could work better. Similar discussions and surveys took place with students and staff. The information gathered from these formed the basis for the strategic directions in our three year plan.

All targets in the previous management plan have been reviewed, including NAPLAN and school based evaluation results, and the data collated by school teams. This planning process has also taken into consideration the value parents, students and staff place on existing programs within the school and the emerging needs of our current and future cohort of students to ensure they acquire the knowledge, skills and experiences to lead successful lives in the 21st Century.
